Abstract

The title of the paper is in Hausa "Siffantawa da fadadar ma'anar kalmar 'Ja' a Hausa. In English it is metaphorical extension of meaning of the word 'Ja' in Hausa. The paper fundamentally discusses how the meaning of word 'ja' extended to several meanings, the paper I uses, the cognitive semantics theory to analyse, how Hausa native speaker extend the meaning of some verbs such as 'ja' in their daily language usage. Some are unconscious to know that the word meaning is extended metaphorically, but this paper will use both primary and secondary source of data to explain that the word as it is a common source of metaphorical extension in Hausa. It will also address the semantic role of the element that relate to the verb in a continuation. Finally the paper found that the verb 'ja' which means to pull, the physical sense can be extended metaphorically to encode: 'Drag,' 'Attract/attention' 'Compete with', 'Tease or provoke' 'Led to' etc. The paper is a contribution to the previous literature of Hausa cognitive semantics and generally to the field of African language studies.

Gabatarwa

Wannan mukala takanta shi ne siffantawa da fadadar ma'ana kalma Ja'a Hausa To mukalar ta danganci ilimin ma'ana a Hausa kuma a ciki za a yi bayani ne, a bangaren adon harshe ne, sannan kuma an raba wannan bincike zuwa kashi biyar, na daya shi ne gabatarwa wanda ya kumshi gabatarwa akan aiki, sannan a duba ma'anar siffatarwa daga bakin masana, sannan, kuma ayi bitar ayyukan masu alaƙa da wannan mukala sannan kuma a kashi na biyu aka kawo dubaru da hanyoyin da aka bin don tattara bayanann wannan bincike sai na uku ya kumshi bayani akan ra'in da aka aza wannan bincike akan sa. A kasha na huɗu ne aka yi bayanin yadda ma'anar Kalmar 'Ja' ta fadada sai kashi na biyar shi ne Jawabin kalmmalawa tare da bayanin abin da bincike ya gano da shawarwari.

Ma'anar Kalmar Siffatawa

Masana da dama sun tofa albarkacin bakinsu game da ma'anar siffantawa: An ba da ma'anar siffantawa da cewa "kalma ko yankin jimla ne waɗanda aka yi amfani da su don a siffanta wani ko wani abu na daban a wata hanya da ta bambanta da yadda ake amfani da su don a nuna cewa abubuwan biyu sun hada siffa daya, sai aka karfafa siffantawar a Ingilishi ya ce 'metaphor is a word or phrase used to describe somebody or something else in a way that is different from its normal use in order to show that the two things have the same qualities and to make the description more powerful (Hornby 2015:931). Kuma an ce "Adon harshe ne wanda aka kwatanta abubuwa. Kuma an kara da cewa siffantawa tana iya zama marar sarƙaƙiya, kuma mai muna fadadar dabi' abubuwa

da siffofinsu. A Ingilishi sun ce “A figure of speech in which a comparison is impleid by analogy but is not stated” kuma ya ce “metaphros may be uncomplicated or eleborate, as in an extended alleopry” (Harris da Hodges: 1995:154) wani kuma ya ba da ma’anar siffantawa da cewa “Adon harshe ce wadda kalma ko magana wadda aka amfani da ita a wani abu, ko aiki, da sauransu sai ta faɗaɗa zuwa ga wani, kuma wannan shi ke kawo faɗaɗar siffantawa a ma’ana (Mathew’s 2005:224) kuma ya ruwaito su Lakoff da Johnson (1980) suna cewa gamammen bayani shi ne amfani da ma’anar wani abu akan wani (Mathews 2005:2256). A Ingilishi shi ne “figure of speech in which a word or expression normally used of one kind of obejct, action etc is extended to another. This may lead to metaphoric change in meaning thus what is now the normal sense of lousy is in origin, a metaphorical extension from the basic sens “full of lice” 2 used by G.P Lakoff in the 1980s of a general pattern in which one domain is systematically conceived and spoken of in terms of another” (Mathews 2005:224).

Kuma an ce “Siffantawa kamar tamka ce kasancewar dukansu sun kunshi kwatarta abubuwa biyu ko wasu lamurra biyu” a Ingilishi sai ya ce “Metaphor is like simile in the sense that both of them involve a comparison between two entities or events”. (Ndimele, 2007:117) sai wani ya ce kuma “Siffantawa na bayanin kwatancen akan abubuwa da lamurra” bayanin a Ingilishi shi ne “The metaphor expresses the comparison between entities and events” (Ogbulogu, 2005:79).

Ayyuka masu alaƙa da wannan maƙala

Akwai ayyukan da aka yi akan wasu kalmomin Hausa waɗanda ake bayanin siffatarwar kalmomin Hausa a kansu. Gasu kamar haka:

- Jagga da Buba (2013) sun yi rubutu akan kalmomin “ci” da “sha” a cikin aikin nasu sun yi bayani yadda ma’anar waɗannan kalmomin ta faɗaɗa.
- Alero (2016) ya yi bayanin yadda kalmomin “ji” da “gani” suka faɗaɗa a ma’anarsu a wurare da yawa ta yadda Hausawa ke amfani da su a maganganunsu na yau da kullum.
- Duk waɗannan ayyuka suna da alaƙa da wannan muƙalar saboda dukansu suna magana ne a kan siffantawa da faɗaɗar ma’anar wasu kalmomi, sai dai sun bambanta ta fuskar kalmomin da suka yi bayani. Saboda haka kawo yanzu ba a samu wani binciken da aka yi akan siffantawa da faɗaɗar ma’anar kalma ji ba.

Dubarun Bincike

A wannan bincike za a dubi yadda Hausawa ke tu’ammuli da wannan kalma a aikace. Kuma za a duba bayanin wasu littafai kamar, kamusai irin su Bargery (1934) da Kamusun Hausa na Cibiyar Nazarin Harsunan Nijeriya, Jami’ar Bayero (2006) da littafan ilimin ma’ana irin su Palmer (2006) da Lyons (1996) da sauransu.

Ra’in Bincike

A ɓangaren ra’i an yi amfani da ra’in ilimin ma’ana mai alaƙa da tunani wato (cognitive semantic) wanda ke bayanin cewa ma’anar kalma tana bayyana tunanin mutanen da ke amfani da ita, wato yadda su ke tunani a kanta kuma anruwaito (Evans da Green, 2006:286) ya yi bayanin ma’ana mai alaƙa datunani, da cewa “ma’anar jumla wadda ake samu a tunani mutun da tasirin abin da mutun ke ji a ma’anar kalma da bambancin salon maganar mutun (Mathews 2005:39). Saboda haka an yi amfani da wannan ra’in don a nuna yadda Kalmar ‘ja’ ke faɗaɗa ma’anar ta a cikin tunanin Hausawa.

Kalmar Ja

A nan za a yi bayanin kalmar “ja” da ma’anar ta, sannan a kawo yadda ma’anarta take fadafa zuwa wurare da dama.

Ja= kalmar aikatau ce mai karins autin sama (s) sannan kuma gaba daya (BW) ke da kalmar. An ba da ma’anar kalmar da cewa “matsar da ko gusar da, wani abu daga wani wuri zuwa wani” (CNHN 2006:210).

Kuma wannan kalmar ma’anarta na iya fadafa wurare da yawa kama (1) Tsokana, (2) [age (3) Dalilin faruwar wani abu (4) Tsawaita (5) karanta (6) Musudda ko kin yarda (7) Tsayar da (8) Fita daga (9) Kara tsawo ko fadi (10) Wahalar da (CNHN: 210).

a. Ja- Gusar da abu daga wani wuri zuwa wani. Misali:

Ali ya ja akuya zuwa kasuwa

Audu ya ja kujera cikin inuwa

A wadannan misalai a kalmar ‘ja’ tana nufin gusar da abu da wani wuri zuwa wani wuri.

b. Ja- Tsokanar mutum ko wani abu

Bala ya Ja Audu fada

Bala ya ja magana

Kande ta jawo fada

A wadannan jumloli kalma ja tana nufin a tsokani wani mutum ko wata dabba. A jumla ta farko ja na nufin mutum ya tsokanin mutum, jumla ta biyu kalmar ja na nufin tsokano dabba, a jumla ta uku kalmar ja na nufin yin wani yanayi ko magana ta tsokana wadda ke sa a yi fada.

c. Ja- Raguwar wani abu daga yawansa.

Rigarsa ta ja sa sama

Wandon Audu ya ja sama

Kogi ya ruwa

A nan ja na nufin abu ya rage yawan da ya kamata ya yi ko ya dauke sama ya kasa yin tsawon da ya kamata ya yi.

d. Ja- Dalilin faruwar abu, wato kalmar ja na nufin dalilin faruwar wani abu. Misali:

Audu ya jawo masu hasara

Halinsa ya ja masa alherin

Audu ya ja mini sabon aiki

Wannan aiki ya ja wani aiki

Duk wadannan jumloli na nuna cewa kalmar ja na nufin wani abu ko wani yanayi ya zamo dalilin faruwar wani abu.

e. Ja- Tsawaita, wato a tsawaita lokacin da aka yin abu. Misali:

Bala a ja aikin har tsawon wata biyu

Audu ya ja hira har tsakiyar dare

An ja lokacin aiki da tsawo

Allah ya ja zamanin ka.

Wato kalmar ja na nufin kara (tsawaita lokaci) da ake yin abu daya lokacin da aka saba. Ko lokacin da ya kamata a yi shi.

f. Ja- Karanta, wata karanta wani abu cikin littafi, musamman littafi mai tsarki kamar Al-Qur’ani. Misali:

Ali ya ja baki an fassara
 An ja masa aya don ya gane
 Na ja masu hadisi

Wadannan misalai na nuna mana cewa ma'anar ja a nan tana nufin karanta littafi, abin da ke cikin littafi mai tsarki na Al-Qur'an ko hadisi, a cikin rubutunsu na Larabci, domin karantawa a larabci shi ya sa aka fassara.

- g. Ja- Musu da ko kin yarda ko tsayawa da shirin yin fada da wani misali:
 Audu ya ja da Bala
 Almajiri ya ja da malaminsa
 Kana da ja akan maganarsa.

Wadannan jimloli sun kawo wata ma'ana ta ja wadda ke nufin rashin yarda tare da kalubalantar wani akan abin da ba a yarda da shi ba.

- h. Ja- Tsayar da, wato tsaida abu ko mutum misali:
 Bala ya ja birki ya tsaya da mota
 Audu ya ja linzzami ya tsayar da doki
 Na ja masabirki akan maganarsa
 Yana magana sai na ja masa birki.

Duk wadannan misalai sun ba da wata ma'ana ta ja wadda ta samo asali daga jan linzzamin doki, ta kai da jan birkin abin hawa, jan brikin abin hawa ya kai ga tsayar da mutum ga yin abu ko maganar da yake yi.

- i. Ja- Fita daga, wato a nan ma'anar ja na nufin fita daga wani lamariko wata harka. Misali:
 Audu ya janye hannunsa daga lamarin
 Bala ya janye jarinsa daga sana'ar
 Audu ya janye diyansa daga makaranta
- j. Ja- {ara tsawo ko fadin abu. Misali
 Audu ya ja yadi don ya kara masa fadi.
 A ja leda, a kara mata tsawo.
 Wadannan misalai na nuna cewa kalmar ja na da ma'anar karin tsawo ko fadi.
- k. Ja- Wahalar da, misali
 Tanko ya ja masa rai kafin ya bashi kuɗi
 Gambo ya ja mini rai game da daukata aiki.

Wadannan jimloli na nuna cewa kalmar ja na da ma'anar wahalar da mutun ko yi masa wulafanci kafin a yi masa abu.

- l. Ja- Motsa sha'awa a kan wani abu, ko daukar hankali akan wani abu. Misali:
 Iya sa tufafinta ya ja hankalinsa a kanta
 Kanshin miya ya ja sha'awata na ga abinci
 Kawar da ta yi ta ja hankali na a kanta.
- m. Ja- Hadawa da, wato kalma ja a nan tana nufin hada wani wuri da wani abu misali:
 Ali ya ja layin wutar lantarki zuwa gidansa
 Ali ya ja layin ruwan fanfo zuwa gidansa.
 Gwamnati ta ja titi daga birni zuwa kauye.

Kamalawa

Wannan mukala ta tattauna akan yadda ma'anar kalmar ja' ta fadafa zuwa wurare da yawa, wannan ya nuna kenan Kalmar 'Ja' Kalmar siffatawa ce wadda ma'anarta ta fadafa, kuma wannan bincike ya fayyace, yadda ma'anar ta fadafa daya bayan daya har kaeshen bayani. Kuma wannan mukala gudurnawa ce ga ci gaban harshen Hausa musamnan bangaren ilimin ma'ana.

Takaitawa

Wannan makala ta tattauna akan siffantawa da fadafar ma'anar kalma Ja a Hausa. A cikin an yi bayanin ma'anar siffantawa sannan kuma an kawo yadda kalmar ja ma'anarta ta fadafa zuwa har wurare goma sha uku (13) tare da kawo bayanin turken ma'anar da ta hada su. Wannan bincike za ya sa a san yadda ma'anar kalmar ja ta fadafa a kan yadda Hausawa ke ta'ammuli da ita a magangannusu na yau da kullum. Kuma wannan bincike za ya sa duk yadda aka ga ma'anar kalmar Ja ta fadafa za a san turken ma'anarta. Ilimin ma'ana.

Abinda Bincike Ya Gano

- a. Wannan bincike ya gano cewa kalmar Ja ma'anarta ta fadafa har zuwa wurare goma sha uku (13).
- b. Kuma a wannan bincike an gano cewa duk fadafar da ma'anar Kalmar 'Ja' ta yi tarken ma'anarta da ya ne kuma shi ne "dagawa" wato dagawa daga wani wuri zuwa wani wuri.
- c. Kuma wannan bincike ya gano cewa duk da yake Kalmar 'Ja' kalma ce mai gaba daya amma ta tattara ma'anoni da yawa a wajen aiwatar da harshe a mu'amala.
- d. Kuma kalma 'Ja' kalma ce mai falsafa a ma'anarta wannan shi ya sa ma'anar ta fadafa da yawa

Shawarwari

Wannan bince yana ba da shawarwari kamar haka:

- a. Masu amfani da harshen Hausa a mu'amala ta yau da kullum ya kamata su san kalmomin da ma'anarsu ta fadafa don su gane su a mu'amalarsu.
- b. Ya kamata a sanar da dalibai irin wadannan kalmomi da yadda ma'anarsu ta fadafa domin su faidanta da hikimomin da ke cikinsu sabon da ana amfani da irin wadannan kalmomin har a wajen aikin shari'a da jaridaci dasaurasu.
- c. Ya kamata masu aikin fassara su rinka lura ta yadda ma'anar kalma ta fadafa a wajen aikin fassara don samar da fassara mai inganci.
