Although English serves as the official language, a recent development is the approval of the National Language Policy, making the use of mother tongues compulsory as a medium of instruction from Primary 1 to 6 (National Language Policy, 2022). The designated mother tongue for each school aligns with the dominant language of its community, aiming to promote local languages, preserve cultures, and support linguistic diversity nationwide.

Previously, education policy mandated mother tongue instruction for the first three years in monolingual communities before transitioning to English. However, challenges, including inadequate instructional materials and qualified teachers, prompted the adoption of the new policy. While officially in effect, full implementation hinges on the government's provision of instructional materials and qualified educators. The renewed emphasis on language study in Nigeria reflects the need for a comprehensive language policy addressing the national language question and its pedagogical implications. Recognizing the indispensable role of English in national development across various sectors, the policy also underscores the necessity to develop local languages, despite the monumental challenges in evolving a national language for Nigeria.

The policy envisions a strategic framework for managing, utilizing, and advancing all linguistic resources in Nigeria. Its overarching goals encompass promoting local languages, preserving cultures, and ensuring the coexistence of Nigeria for self-actualization, national unity, and socio-economic development. Applicable to governmental entities, non-profit organizations, and diverse social, administrative, and communication activities, the policy outlines language usage guidelines in education, media, information technology, legislature, judiciary, governance, administration, politics, town planning, entertainment, trade, banking, science and technology, health, environment, agriculture, and security.

A key aspect of the policy is the adoption of the language of the immediate community model, assigning functional roles to languages to align with national development needs. The policy also delineates the functions, responsibilities, and roles of governments, institutions, agencies, and other stakeholders in language development, financing, implementation, and policy monitoring and evaluation (NLP, 2022).

### **Importance of National Language Policy in Nigeria**

A nation's language forms the bedrock of its identity, culture, and developmental trajectory. In Nigeria, celebrated for its remarkable linguistic diversity, the National Language Policy (NLP) emerges as a crucial instrument for shaping the harmonious coexistence, inclusiveness, and effective communication among its myriad ethnic groups.

The NLP in Nigeria unfolds as a multifaceted strategy, with a primary emphasis on the preservation of cultural heritage. Recognizing the richness embedded in each ethnic group's cultural tapestry, the policy actively promotes the use of indigenous languages in key domains such as education, administration, and communication. The policy underscores the importance of promoting indigenous languages alongside the official language, English. This dual-language approach serves to bridge communication gaps at the grassroots level, fostering inclusivity. By enabling individuals to express themselves comfortably in their native languages, the policy facilitates active participation in various spheres of life, including governance and decision-making processes. Osoba (2017) highlights how this linguistic inclusiveness contributes to a more vibrant and representative democratic framework.

The NLP's recognition of language as the foundation for education marks another significant stride. Understanding that children learn most effectively in their mother tongue during the early stages of education, the policy advocates for the use of indigenous languages as a medium of instruction in primary education. This approach not only enhances comprehension and cognitive development but also strengthens the cultural connection of children to their roots. Eze (2020) underscores the positive impact on educational outcomes, citing improvements in academic performance and reductions in dropout rates.

Economic empowerment, intricately linked to language, emerges as a driving force behind Nigeria's NLP. Encouraging the use of indigenous languages in commerce and trade, particularly in regions dominated by specific ethnic languages, the policy opens avenues for economic growth. By leveraging local languages in business transactions, marketing, and advertising, the NLP promotes economic empowerment among diverse ethnic communities. Ogunnaike (2017) observes how this approach facilitates small-scale businesses in tapping into local markets, fosters entrepreneurship, and contributes to grassroots economic development.

In essence, Nigeria's National Language Policy is a comprehensive framework that goes beyond linguistic considerations. It intertwines with the preservation of cultural heritage, facilitates effective communication, lays the groundwork for educational advancement, and fuels economic empowerment. By doing so, the policy becomes a dynamic catalyst for fostering unity, inclusivity, and sustainable development in a nation characterized by its rich linguistic tapestry.
