### NOMINAL MODIFIERS IN OBOLO

### **Abstract**

This study describes nominal modifiers in Obolo. Obolo native speakers are found in Akwa Ibom and Rivers States of Nigeria. Being a descriptive study, the presented data are drawn from the intuitive knowledge of the author and corroborated by other native speakers of Obolo. Nominal modifiers in Obolo with certain restrictions can occur only at pre-head or post-head and some at both positions in relation to the nominal it qualifies. The paper identifies adjectives, determiners, quantifiers, associative constructions, demonstratives, intensifiers, emphasizers and the relative clause as sub-classes of Obolo nominal modifiers. The data analysis reveals that Obolo modifiers are predominantly post-modifiers.

### Introduction

A modifier is a word, phrase or clause that provides information about another word in the sentence. There are different types of modifiers. Nominal modifiers are words that provide information on a noun or nominal. A nominal is a word that can function as a noun. A nominal if not rightly placed can be described as either misplaced or dangling. Nominal modifiers are words that specify the reference of a nominal (Ndimele, 1996). To qualify a nominal, they are found in the vicinity of words that have the grammatical function of nouns. Nominal modifiers are found in constructions of nouns or pronouns because they limit, restrict or specify the reference of nouns and pronouns (Aleruchi, 2017).

The combination of noun modifiers and a noun forms the structure of a noun phrase. The constituents of a noun phrase are modifiers which are either placed before the noun or placed after the noun (Isaac, 2022). When they are placed before the noun, they are termed pre-modifiers and post-modifiers, when placed after the noun which serves as the head of the phrase. In other words, nominal modifiers are found in noun phrases. The head word in a noun phrase is a noun. Nominal modifiers in the construct of a noun phrase provide information that relates to the head of the construction. For example in the English language, the word *beautiful* in the shown sentence is a nominal modifier- *The beautiful girl won the award*. The nominal modifier, *beautiful*, modifies the head- *girl- in* the noun phrase- *the beautiful girl*.

This paper describes the nominal modifiers in Obolo. Obolo is a Lower Cross-language, a sub-phylum of Niger-Congo. Obolo is an East Benue-Congo language in Bantoid-Cross (Eberhard, 2022). The languages of Cross River are bounded by Ijoid, Edoid, Igboid, Idomoid, Bantoid and Bantu speakers (Faraclas, 1989). Obolo is spoken in Eastern Obolo Local Government Area in Akwa Ibom State and Andoni Local Government Area of Rivers State (Ager, 2021; Kari, 2019).

The language can be differentiated into three main dialects: the Eastern Obolo dialect (Okoroete, Ibot Obolo), the Western Obolo dialect (Ataba, Asarama, Unyeada), and the Central dialect (Ngo).

The main aim of this paper is to examine nominal modifiers in Obolo. The specific objectives of the paper are to describe the forms of nominal modifiers and the positions they occur in Obolo. The paper is divided into six sections. Section one contains the introduction. Sections two and three provide empirical review and methodology respectively. Section four has the different forms of nominal modifiers in Obolo. Section five examines noun-modifier order. Section six presents a matrix on the positions of nominal modifiers in Obolo. The next section provides an empirical review of nominal modifiers.

## **Empirical Review**

Dryer (2010) examined noun-modifier order in Africa. The primary thesis of his paper was that languages in Africa exhibit a greater tendency to place modifiers after nouns than other languages in the world. Dryer used data from a database of 1,600 languages by comparing languages in Africa with other areas of the world as well as the distribution of nouns and modifiers. The data presented showed the order and distribution of adjectives and nouns, demonstrative and noun, numeral and noun, genitive and noun, relative clause and noun, and lastly, definite marker and noun. The paper concluded that nearly all categories of modifiers follow the noun and more often in languages in Africa than languages elsewhere in the world. The trend was noted to be well pronounced among the Niger-Congo, the Nilo-Saharan and the Chadic languages.

Aleruchi (2017) presented nominal modifiers in Ikwere, an Igboid language spoken in four (Ikwerre, Emohua, Obio/Akpor and part of Port Harcourt Local Government Areas (LGAs)) of Rivers State of Nigeria. She adopted a descriptive approach in the analysis of nominal modifiers in the language and identified adjectives, qualificatives, demonstratives, quantifiers, numerals, possessives and relative clauses as the seven sub-classes of nominal modifiers in the language. She observed that all nominal modifiers predominantly occur in the post-head position, but few of them, in addition, occur in the pre-head position.

Isaac and Barikpe (2022) studied nominal modifiers in Kana. They observed that there are 10 nominal modifiers in Kana. It was also observed that though all the modifiers freely occur with the noun, there is a constraint on the maximum number of modifiers a noun can co-occur with at a time within a single NP configuration. In Kana, the NP can accommodate five pre-head modifiers and three post-head modifiers at a time. A linear order of the relative position of modifiers when they co-occur within the Kana NP, the relative position of certain word classes is fixed. Isaac and Barikpe (2022) showed the linear order in pre-modification and post-modification of the noun in a noun phrase as follows: pre-head modifiers —quantifiers, pluralizers, possessives, intensifiers and adjectives. For post-head modifiers, the prepositional phrase/demonstrative comes before the relative clause.

## Methodology

The data presented are drawn from fluent competent speakers of Obolo to corroborate the intuition of the author. Texts and library materials consulted form the secondary sources of data. The Ngo dialect which is favoured by the Obolo Translation Committee is used in this study.

#### **Modification of Obolo Nominals**

Pre-head and post-head modifiers are attested in the grammatical structure of Obolo. Some Obolo nominal modifiers are used only as pre-modifiers or post-modifiers. A few of these modifiers are used as pre-modifiers and post-modifiers. Hereafter, the following nominal modifiers in Obolo are examined: adjectives, intensifiers, comparative forms, associative constructions, demonstratives, qualifiers, numerals and possessive pronouns.

# **Adjectives**

By syntactic function, an adjective modifies a noun. Adjectivals are nominal modifiers because they modify the reference of nominals. Obolo adjectives are in different forms as illustrated. a. Underived Adjectives- Underived adjectives are adjectivals which are not derived from verbs or nouns.

```
(1) i. áyá - new
ii. sóntíík- small
iii. uja - beautiful
```

These underived adjectives are used as pre-modifiers as they can be only placed before the nouns they qualify.

```
i. aya ikpa 'new book' mod N
ii. sontiik min 'small drink' mod N
iii. uja gwun 'beautiful child' mod N
```

c. Partial reduplication of some underived adjectives expresses the quality of 'very', intensity of the property or quality expressed by the root adjective. Examples (3)

```
    i. áyá – new > áyáyá 'very new'
    ii. ílé – big > ílílé 'very big'
    iii. sóntíík – small > sóntítík 'very small'
```

These forms can be used either as premodifiers or postmodifiers. Examples (4)

- i. **áyáy**á íkpá 'new book' pre-mod N
- ii. íkpá áyáyá 'new book'N post-mod
- iii. **ílíl**é ámà 'big town' pre-mod N
- iv. ámà ílílé 'big town' N post-mod

These forms are realisable in the language but are used as topicalised forms. In the use of 4 (i)  $\acute{a}y\acute{a}y\acute{a}$  (ikpá 'new book', a speaker's interest might be on  $\acute{a}y\acute{a}y\acute{a}$ , the newness of the book. In 4 (ii) ikpá áyáyá 'new book', a speaker's interest is on  $\acute{i}kp\acute{a}$ , the book.

b. Verbal adjectives derived from reduplicated verbs.

```
    i. fit 'blackened' → ófifit 'black'
    ii. tèm 'cook' → étêtèm 'what is cooked'
    iii. kàlà 'fry' → ékâkàlà' what is fried'
```

Except *ofifit* which can be used at pre-nominal and post-nominal positions, the other adjectives derived from partial reduplicated verbs can only be used at post-nominal positions as shown in example 6.

```
i. ofifit otin 'black pot' mod Nii. otin ofifit 'black pot' N mod
```

The examples above show that the modifier can either be placed before or after the noun.

The verbal adjectives derived from reduplicated verbs (5i-iii) when placed before a noun become a simple sentence. In (6iii) the construct is 'what is cooked' becomes 'they cooked the food' when the derived adjective is placed before the noun as shown in 6(iii). The construct with a pre-nominal reduplicated verb becomes a simple sentence with an inflected verb + noun. The reason for this is that an inflected verb in Obolo is person-marked (Gladday 2006). In example 6(iv) below, the inflected verb is a person marked by a subject clitic which produces a subject and predicate structure giving rise to a simple sentence.

Derived adjectives are only used as post-modifiers as shown in 6(iii), there is a change in meaning when the derived adjective is placed before the noun 6(iv). Where the derived adjective is placed before the noun, a simple sentence of SVO is formed.

c. Adjectives derived from verbs through the process of prefixation are represented below (7).

These adjectives derived from verbs through the process of prefixation are only placed after the nouns they qualify.

From examples 1-7, Obolo adjectives are constrained by locality. Underived adjectives are used as pre-modifiers while derived adjectives are used as post-modifiers. They are placed either before or after nouns. More examples are given below:


- 8) Áyílé ìkàrióón lék ádà íbòt ílé. PN NEG know body pepper head big. Ayile does not know big pepper.
- 9) Ónyà**n** î**jàán**.
  moon be beautiful
  The moon is beautiful.
- 10) Îrè áyá ónyàn. be new moon It is a new moon.

### **Intensifiers**

Intensifiers are nominal modifiers derived from adjectives. Intensifiers in Obolo are derived through the prefixation of m- to verbal adjectives. In other words, the prefixation of m- 'very' to verbal adjectives results in the derivation of the following intensifiers. Examples:

These intensifiers can only be used as post-modifiers. Examples 12:



ii. ékwút míjònó \* míjónó ékwùt cloth very long very long cloth

These forms can only be used as post-modifiers.

# **Emphasizers**

In the Kana language, Ikoro (1996) used the term 'emphasizers' to express nominal modifiers that can bring a noun into prominence. In Obolo, the phrase 'ata lek' which literally means 'good body' can be used to express the emphasizer 'really'. Emphasizers in Obolo are used as premodifiers. Examples (13), the emphasizers are in bold form:

i. **àtálék** ìnó 'a real thief' EMP N

ii. **àtálék** ánàm 'a real animal' – a foolish person EMP N

iii. átálék íjò mgbo 'really bad time'EMP Adj N

iv. **àtálék** utop ínórìè 'a real good meal' EMP Adj N

v. **àtálék** ìjó ísí 'a real ill luck' EMP Adj N

### **Associative Construction**

In an associative construction, two or more nouns occur together as a morphological unit. The examples of associative construction presented below show two nouns placed together as a unit. The first noun serves as the head. The noun or nouns that follow the first noun are possessed by the first noun or are associated with the first noun (Akan n. d.). In the examples presented below, the second noun in the associative construction acts as a post-modifier. Some examples are shown below with the head in italics.

(14) *ókwùn* Ásùk basket PROP name 'Asuk's basket'

(15) ókwùn irîn basket fish 'fish basket'

(16) újì mbòm canoe fishing 'canoe for fishing'

Sometimes, an associative construction can be serial where more than two nouns are used in the construction without an intervening word.

(17) újì mbòm Ásùk canoe fishing Asuk 'Asuk's fishing canoe'

In example 17, *uji* is the head of the construct. The other nouns act as modifiers which are used for specificity.

#### **Determiners**

Determiners are modifiers that also co-occur with nouns. They modify the meaning range of nouns. Articles, possessives, quantifiers, numerals and demonstratives are determiners.

### **Demonstratives**

A demonstrative is a word that refers to the position of a noun. It shows whether the noun is far or distant from the speaker. Demonstratives basically are proximal and non-proximal or distal (Ndimele, 1996). Demonstratives have the attribute of demonstration in their reference. In a discourse, demonstratives have the supplementary gesture where sometimes the act of pointing makes for definiteness. Some English examples are *this, these, that, those, you, he, she,* and *it.* It is important to note that demonstratives in Obolo are mainly deictic.

The following proximal pronouns and adjectives show the parameter of distance.

(18) i) yì 'this ...'
ii) yâ 'that ...'
iii) kéyí 'this very'
iv) chì 'these'
v) chà 'those'
vi) kèchì 'these very'
vii) kèchílò 'those ones'
```

These demonstratives are used in the following sentences. They show nouns that are visible and close to the speaker. These sentences can be gestural as the speaker may add the act of pointing to his expression. The demonstratives are used as post-modifiers.

(19) Énēnwààn yì ìrè ngà ná. woman this is mother mine This woman is my mother.

Some of these demonstratives act as proximal pronouns. In 19, yi acts as a post-modifier, with the prefixation of e to yi, éyì a proximal pronoun is derived. In example 20, éyì is a nominal that cannot be further modified.

- (20) **Éyì** ìrè ókwùn <u>n</u>á. this is basket mine This is my basket.
- (21) Ókwùn **kèyì** ìrè èyí kìbà<del>n</del>. basket this very is be theirs This basket is theirs.

The demonstratives ya is used for a referent that is far from the speaker and may or may not be visible but is known by the speaker and the addressee. The demonstratives shown in the examples (22-24) presented below which are used for specificity are post modifiers.

(22) Ókwùn **yà** ìrè èyí ñá. basket that is be mine That basket is mine.

- (23) Ókwùn **éyà** ìrè èyí <u>n</u>á. basket that one be mine That basket is mine.
- (24) Ògwú **kèyíl**ộ ìrè ìnó. person that very is thief. That person is a thief.

## **Ouantifiers**

Quantifiers are nominal modifiers that express the idea of quantity (Ndimele, 1996). The modifiers in the examples presented below are highlighted.

The highlighted forms (examples 25-35) show that quantifiers are used as only pre-modifiers or as post-modifiers except example 28- ògbògbò – which can be used as a pre-modifier and a post-modifier ògbògbò ènê/ ènê ògbògbò.

## **Numerals**

A nominal can be modified by a number. A number is expressed through a numeral. Numerals modify countable nouns. Obolo nominal can be modified by the two forms of numerals: cardinal and ordinal.

### a. The Cardinal

Cardinal numbers are used for counting. At present, Obolo has a modern counting system which is up to a trillion. This is made possible by an additive process through the modification of the basic units, from number one to nine. The table below gives an overview of Obolo's modern counting system.

## b. The Ordinal

Ordinal numbers specify items in a series. The specifier 'oso' is used after the first number in a series. Except for the first ordinal that is used as a pre-modifier, other ordinals are used as postmodifiers. This is in line with Efik where cardinal numbers are post-nominal (Mensah 2011). Examples (36):

- i. àdàsí > first 'ádásí íkpá > first book'
- ii. òsô íbà > second 'íkpá òsô íbà > second book'

#### **Possessive Pronouns**

Possessive pronouns are used as nominal modifiers. The examples below show how these pronouns modify nouns. The examples below show possessive pronouns as post-modifiers.

### **Relative Clauses**

A relative clause is a dependent clause that provides more information about a noun or a noun phrase (COBUILD n.d). In English, the relative clause is a post-modifier. The relative clause in Obolo post-modifies the referent noun.

37. Ataije, **ogwuonunu me iyakwut**, ire ogwu ikpa.

PN person Adverbial be person book

Ataije, the person who came yesterday is a literate person.

The highlighted construct in example 37, is a relative clause which modifies the proper noun-Ataije. The relative clause is a post-modifier.

### **Noun-modifier Order**

Every language has rules that order nominal modifiers (Lusekelo 2009). A nominal can have more than one modifier. In such instances, some modifiers come before others. The examples presented in 38 show the noun-modifier ordering in Obolo.

Examples 38:

i. one modifier

(a) **owu** ile 'big house'

house big

N post-mod

(b) **gwun** mijaan 'very beautiful child'

child INTEN beautiful

N post-mod

(c) **otin** ofifit / ofifit **otin** 'black pot' pot black black pot
N post-mod

The examples shown above present modifiers more as post-modifiers of nominal.

ii. more than one modifier

(d) asabon ofifit **otin** go 'five small black pots' small black pot five size colour N Numeral

(e) usini **alala** okuket ile otatana 'some big clean white plates' some plates white big clean

(e) usini ikpele okuket **alala** otatana 'some big clean white plates' some big white plates clean

(f) oka okpa ofifit **otin** kechi 'these dirty old black pots' old dirty black pots these

(g) uja nsabon ubon **ebibaan** go 'five rich beautiful young women' beautiful young rich women five

Examples (d) and (g) above show that where there is more than one nominal modifier, they are placed before and after the nominal they modify. The placement as either a pre-modifier or post-modifier has constraints. Examples (d) and (g) show that the number modifier can only be used as a post-modifier.

### Matrix on the Modification of Obolo Nominal

The placement of Obolo noun modifiers is shown on the matrix presented below.

# **Summary**

In terms of typology, Obolo nominal modifiers are predominantly post-modifiers and align with the observation (Dryer 2010) that most languages in Africa place modifiers after nouns.
